Given the fact that it will take a while before the Vision congresses will be in America or Europe, we strongly support the organization of local ISLRR meetings. In October 2008, Susanne Trauzettel-Klosinski organized a wonderful meeting in Tübingen, Germany (From Eye to Mind), that

focused mainly on neuro-ophthalmology. There are plans to organize more of these small meetings in Europe. For example, Gust Colenbrander, Susanne, and I will host a meeting during the World Congress of Ophthalmology (Berlin 2010) and of course there will be the Association for Research in Vision and Ophthalmology (ARVO) meetings. Still, there are plenty of opportunities to organize local meetings especially meant for the professionals in our field. A last message regards our journal, Visual Impairment Research. We have been informed that the publication cannot sustain itself as before, so it will no longer be published. The ISLRR Board is working on this matter, and the possibility of an internet journal is being considered as well.

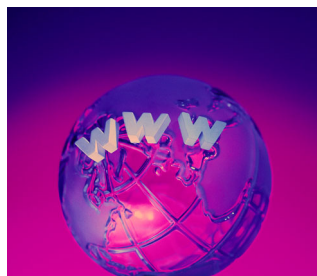

## ISLRR Members Have Access to Research Through Society's Website

ISLRR members have access to valuable research through the members portal on ISLRR's website ([www.islrr.org](http://www.islrr.org)). By gaining access through the use of user names and passwords, members can search Volumes 1 through 10 of the *Visual Impairment Research* journal, download the report of the Oslo Workshop on Low Vision and search abstracts from the Vision 2002 Conference. In addition, only members



have access to Low Vision: the Reference, a searchable bibliographic database of low vision literature with over 11,000 references and citations. This helpful desktop resource allows you to search by author, title and year.

Search results give you the name of the article, authors, date, publication, volume number, and page numbers, allowing you to easily find the publication and research paper.

The ISLRR's website has the ability to be viewed in Spanish, French and Russian, as well as in English.
